# Choosing a Foster Care Agency

*Be part of a supportive network of more than 300 foster homes  
across more than 20 counties in upstate New York.*

Congratulations on deciding to be a foster parent! Now comes the next part—finding the right team to support you in your journey. In New York state, you have a choice of agencies that can help you navigate state and county regulations, provide extra support, and provide additional resources, 24/7/365. Your choice can make all the difference between a successful parenting experience or a challenging one. We hope the following hints will help you on your journey to becoming a foster parent.

## Do your homework!

Identify all the agencies that serve your area, and talk to them all. How did each call make you feel? Were your calls welcomed? Were your questions answered respectfully and clearly?

## Ask questions.

- Why should foster parents choose them?
- When and how often and when do they hold orientation meetings?
- Is there a stipend to cover costs associated with a youth in care? How much?
- Do they routinely place older children?
- Have they worked with families like yours?

## Attend orientation meetings at all the agencies you feel comfortable with.

At the meeting:

- Did you feel comfortable?
- Was the information clear, realistic and detailed?
- Was the staff respectful and encouraging to you as a prospective parent?
- Did they speak of the children and their birth families respectfully?
- Were you able to hear from experienced parents who fostered and/or adopted through the agency?
- Can you follow up by phone or email with the staff or volunteers if you have more questions?
- Is there a cost for any part of the services?
- What kind of agency support will be available after a child is placed in your home?
- How are those services funded?
- Did they downplay the difficulties of the children who need placement, or did they overemphasize the negative?
- Look for a balance of realism and enthusiasm.

## After contacting appropriate agencies, think about your reactions to each one.

- Does the agency employ people you trust and feel comfortable with?
- Does the agency have similar goals and beliefs to your own?
- Is proximity and/or transportation an issue?
- Does the agency have experience with the kind of child(ren) you have in mind?
- Does the agency have experience with families like yours?

## Time to compare and contrast.

Once you've completed your "research," choose the agency that "fits" you, your family, and your lifestyle the best. Feel free to discuss your choice with others whose input you value, but remember that the final decision is up to you. No agency is perfect; no prospective parent is perfect; with the right agency, however, you can make a difference to a child that will last a lifetime.
